TUITION PAYMENT OPTIONS (please check one):

- I wish to pay the year's tuition in full by July 15th and receive a **8% discount** or by September 1st and receive a **6% discount**.
- I wish to pay the year's tuition in two installments (July 15th and December 1st) and receive a **5% discount** (September 1st and January 1st) and receive a **3% discount**.
- I wish to have my monthly tuition payments debited automatically from my checking or savings account. I choose to pay on the **1st** or the **15th** of each month. In the case of a return for insufficient funds, I understand that a late fee of 10% will be assessed as well as an NSF fee of \$25.00. Please circle: Start payments in July, August or September. End payments in May or June.
- I desire to make monthly tuition payments directly to the WCCS office. I understand that there is a \$10 per month processing fee for this service including credit card payments. These payments are due on the 1st and late after the 10th. I understand that a 10% late fee will be assessed if payments are received after the 10th. Please circle: Start payments in July, August or September. End payments in May or June.

*If no payment option is selected, your account will automatically be set with payments being sent directly to the office. Payments are due on the 1st and late after the 10th. A \$10 per month processing fee will be charged.

FINANCIAL POLICY: If payment is received late, a late charge of 10% will be assessed on your account. If the account is not paid in full by the end of the month, the student(s) will be excluded from class until such time as the account is paid in full, unless prior arrangements are made. If you desire to withdraw your child from school, a minimum of two weeks written notice must be given to the school office or two weeks of tuition will be charged to your account balance.
